PAINTBALL WILL BE AVAILABLE AT ALL OUR PSW DISTRICT YOUTH SUMMER CAMPS

PAINTBALL DETAILS

Cost: \$20 for equipment rental for the week. Includes 100 paintballs.

You can pay by cash, card or check. Checks must be made out to: PSW District. Give your signed form and payment to your youth pastor/leader. They will turn your form and payment in at registration on the first day of camp.

Release Form: Students wanting to play paintball must bring a form with student and parent/legal guardian signature. If either signature is missing, the student will not be allowed to play. Please bring forms with you to camp or email to pswnextgen@foursquare.org

Restrictions: Campers MAY NOT bring their own paintball guns. Campers are allowed to bring their own masks.

Dates: Paintball will be available during free time at all youth (6th-12th grade) summer camps:

Staff: The PSW District staff will have a trained team leading paintball.

Refills: Each player will be given 100 paintballs at the start of the week. If you need more paintballs it will cost \$5 per 100.

The Rules:

- 2) ALWAYS turn the safety on and use the barrel cap/cover
- 3) NEVER Point a gun at a person without a mask on
- 4) NEVER shoot someone that is less than 10 feet away the rules!!
- 5) OBEY All Staff and referees on the paintball field

If you break any of these rules you will be asked to leave the paintball field immediately without a refund. Also you could be sent home from the camp depending on the offense. Be safe and obey the rules!

WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT


Please bring this form to camp with BOTH signatures.

In consideration of participating in Paintball games and events hosted by Camp Cedar Crest and the Pacific Southwest Foursquare District of Churches, I represent that I understand the nature of this activity and that I am qualified, in good health and proper physical condition, to participate in such activity. I fully understand that this activity involves risks of serious bodily injury including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the activity, the conditions in which the activity takes place, or the negligence of the "Releasees" named below, and that there may be other risks not known to me or not readily foreseeable at this time. I fully accept and assume all such risks and all responsibility for losses, cost and damages I incur as a result of my participation in the activity.


I hereby release, discharge, and covenant not to sue Camp Cedar Crest, the Pacific Southwest Foursquare District of Churches, or the International Church of the Foursquare Gospel, its respective administrators, directors, agents, officers, volunteers or employees or other participants, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which the activity takes place (each considered one of the "RELEASEES" herein) from all liability, claims, demands, losses or damages, on my account caused or alleged to be caused in whole or in part by the negligence of the "Releasees" or otherwise, and agree that if, despite this release, waiver of liability and assumption of risk I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any loss, liability, damage or cost, which ever may incur as the result of such a claim.

By signing below I agree that I have read the Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement, and agree to the terms specified within. I understand that I have given up substantial rights by signing it, and have signed it freely and without any inducement or assurance of any nature, and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law, and agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect.
